The Faculty of Tourism studies – Turistica is hereby publishing a call for enrolment in the study year 2018/19 to the following master's degree study programmes:

- *Tourism*
- *Heritage Tourism* (interdisciplinary study programme carried out together with the Faculty of Humanities of the University of Primorska)

STUDY PROGRAMME: **HERITAGE TOURISM**

The interdisciplinary Master's degree study programme is carried out by the Faculty of Tourism Studies Turistica (coordinator) and the Faculty of Humanities, both members of the University of Primorska.

Type of study programme: **master's programme**

Duration: **2 years (four semester), 120 ECTS**

Mode of study: **full-time**

Location of study: **Portorož**

Conditions for enrolment in the programme:

Enrolment to first year is possible for those who have completed:

- Final Degree (graduation) in the study programme at the first university study level in areas of tourism, humanities, social and natural sciences;
- Final Degree (graduation) in the study programme at the first university study level in other study areas: if a candidate passed the examination prior to entry from the contents, which are essential for the continuation of the study (basic knowledge of humanities or social sciences or tourism or natural sciences) in the range of a minimum of 10 Credit Points and a maximum of 60 Credit Points;

The number and set of differential exams are determined by the previous study; the number and contents of exam obligations are decided by the Commission of UP FHS and UP FTS Turistica. Differential exams or additional obligations identified candidates must pass before enrolling in the study program, in which case it can be referred to as obligations in the framework of an optional course of study in programs prior to entry in the master's study program.

The number of differential exams can be changed in the event that a student - on his/her request – asks to recognize exam(s) of equal or similar quality, carried out in preliminary study program.

The conditions to enrol are fulfilled also by candidates, who have completed a comparable study programme abroad, and who, in accordance to Slovenian law, have a recognised right to continue their education within the study programme.

Selection criteria in the case of limited enrolment:

- average grade of the undergraduate study – 70% of points
- grade of thesis – 30% of points

In the case that the undergraduate student has not written his/her thesis or a final project work, the average grade of undergraduate study accounts for all points.

THE STUDY PROGRAMME WILL BE DELIVERED IF THERE ARE AT LEAST 15 STUDENTS ENROLLED INTO THE 1ST YEAR.

APPLICATION FOR ENROLMENT TO THE 2ND YEAR (ACCORDING TO THE REGULATIONS FOR TRANSFERS OR UNDER THE CONTIOTIONS FOR A FASTER PROGRESS)

A student can transfer between study programs under the conditions defined by the study programme (if they fulfil the obligations for the enrolment to a starting year of the other programme and if there are available places) and in accordance with the Higher education law or the Measurements for

transferring among the study programs accepted by the Council of the National agency of the Republic of Slovenia for higher education quality.

Transferring among the programs means concluding studying at the first programme and starting with another one. The first programme is the programme from which the student is transferring. The first study programme can also be all the study programmes of the same cycle, in which the candidate already carried out the study obligations and which can be recognised in another study programme. The other study programme is the programme into which a student has been transferred.

Transfers are possible between programmes that:

1. at the conclusion of the studies enable acquirement of similar competence and
2. between which at least half of the study obligation can, according to the ETCS system, be recognized from the first study programme that are similar to the mandatory subjects at the other study program.

According to the number of recognized obligations from the first study programme in the Republic of Slovenia or abroad a student can enrol into the same or higher year of study in the other study program.

At the transferring there can be recognized:

1. comparable study obligations that a student passed at the first study program
2. comparable knowledge obtained through informal education.

Knowledge obtained prior to enrolment can be proven by appropriate certificates. Upon the candidate's application the Senate of UP FTŠ Turistica decides whether the performed obligations and obtained knowledge is appropriate and comparable.

In accordance with the Regulations for transfers between study programs and internal acts at the University of Primorska a student can enrol into a higher year of study of the other study programme if during the recognition process the needed number of credits and those credits, which are the condition to enrol to a higher year of the study programme, are recognised.

IN CASE OF ENROLMENT RESTRICTIONS the candidates are selected on the basis of the criteria, valid for the selection when there are enrolment restrictions for the enrolment into the first year of study.

Enrolment to first year is possible for those who have completed:

-study programmes of the level from the following fields: tourism, personal services, social studies, business and organisational studies, law, humanities, journalism and informing, health, social work, transport services, environment protection.

- The study programme of the first level from other fields on condition that before studying a student passes the exams from: Introduction to tourism (6ETCS) and Business system management (6ETCS).

Selection criteria in the case of limited enrolment:

-average grade of the undergraduate study – 70% of points

-grade of thesis – 30% of points

In the case that the undergraduate student has not written their thesis or final project work, the average grade of undergraduate study accounts for all points.
